Visit www.pro-hillclimb.org for more details. The class runs black number plates with white numbers.</p>	<p>450 Pro class qualifying begins at 9am on Saturday on an all-new, 270-foot hill. Top 15 in this qualifier, (plus top 3 from Sturgis) will advance to the main which starts @ 3:30pm on Saturday. The rules have changed to allow all 4-strokes, as well as 2-strokes, up to 450cc to compete. Bike must have one working brake and tether kill switch and this class does not allow riders to run nitrous or nitro, but there are no limits on wheelbase, and rubber paddle tires, are okay, (steel is NOT allowed). ALL entries must be postmarked by September 8. You MUST be an annual NAHA member (\$75) to run in this class. There is NO onsite registration for this class! You MUST enter by September 8!</p>
