All riders will pay at the gate and then get their admission refunded when they signup or check in, (for each day that they are competing).</p>	<p>450 Exhibition class qualifying begins at 9am on Saturday on the 250-foot hill. Top 17 in this qualifier, (plus top 3 from Sturgis) will advance to the main which starts @ 9:20am. on Sunday. Acceptable engines are: 4-Strokes up to 450cc (singles or twins) and 2-strokes up to 300cc (singles or twins). Bike must have one working brake and tether kill switch and this class does not allow riders to run nitrous or nitro, but there are no limits on wheelbase, and rubber paddle tires, are okay, (steel is NOT allowed). ALL entries must be postmarked by September 9. You MUST be an annual NAHA member (\$50) to run in this class. There is NO onsite registration for this class! You MUST enter by September 9!</p>
